## General Information

It is recommended that college bound students take the ACT and/or SAT in late spring of their junior year. It is also recommended that juniors take the PSAT/National Merit Scholarship Qualifying Test prior to taking the ACT/SAT.

To qualify for ILLINOIS STATE SCHOLAR recognition the ACT must be taken in February, April or June of the junior year. All juniors must answer “Yes” to question W on the ACT registration folder.
